### CHARTIERS TOWNSHIP BOARD OF SUPERVISORS MEETING DECEMBER 15, 2009

Mr. Harlan G. Shober, Jr. – Chairman called the regular meeting to order at 7:00 p.m., Tuesday December 15, 2009. At this time he asked all present to stand for the pledge of allegiance.

### **ATTENDANCE:**

Attending this evenings meeting were Supervisors A. William Kiehl, Richard W. Metzler and Mr. Shober. Additionally in attendance were James Liekar-Solicitor; Samuel R. Stockton-Township Manager; Edward Jeffries-Public Works Director; Harold Ivery, Jr.-Planning/Zoning Officer and Wendy Williams-Recording Secretary.

### **VISITORS TIME:**

Rea Jones 445 Welsh Rd Washington, PA. 15301

Mr. Jones showed concern of the Township's use of the Ullom Road Property as a shooting range and tractor pull area. Residents are now using it as a walking trail and bike trail.

Michael Yeager 29 Ullom Rd Washington, PA. 15301

Lives across the street from the Ullom property and objects to the proposed shooting range. Mr.Yeager expressed concern about water being drawn from a tributary for gas drilling operations. He also people disposing tires and speeding on the road.

For the record (referring to Mr. Altieri's comments provided at the December 1, 2009 meeting) the scheduled workshops for the 2010 budget Tuesday October 20, 2009; Wednesday November 4, 2009 and November 17, 2009, at 6:00 p.m., were advertised in the Observer October 15, 2009 (referring to a proof of publication from the Observer).

Also, in 2008 the Fire Departments allocation went from \$74,000 to \$80,000. Allocation had doubled.

## Township Manager – Samuel R. Stockton

Arranged and attended meetings on 2010 health care.

Took several complaints on gas well flaring. Called Jim Cannon of Range Resources for information on the flare.

Placed ad for police officer.

Joe Yankovich of Congressman's Murtha's Office returned my call concerning the 313 money for the Canton/Chartiers Joint Sewage Project. He stated the money is committed to the project and will be available in 2010. He could not tell me when in the year it is available, but will find out and contact me.

Met with Gary Bistarki who stuccoed the Fire Station. He will measure the building and submit a cost estimate. Project cannot begin until spring, but the price submitted will hold until then. Materials and labor has 12-year warranty.

In contact with Larry Gasparato of PENNVEST. Arranged a conference call on December  $9^{th}$  at 2:30P.M. to discuss the application.

Police Department furnace is repaired.

South Strabane will take 3 traffic signals in the Meadowlands Interchange Project and Chartiers Township will have one. South Strabane will notify PA DOT and the signal permits will be drafted accordingly.

Received application for minimum use driveway from PA DOT for the Ullom Road Property.

Called Joe Puce Awards and will go to his place of business tomorrow to select a plaque for Ted Sankey.

Arranged and attended a meeting with the Fire Department.

I have contacted seven banks for proposals for a possible loan for the Route 18 Joint Sewage Project.

Correspondence of Note

Mark West Liberty and Midstream and Resources L.L.C. has notified the Township they will be applying to PADEP for an Air Quality Plan Approval to install two natural gas heater a stabilizer and depropanizer for condensate and additional natural gas depropanizer. Anyone wishing to view the application may do so my making arrangements with PA Department of Environmental Protection Southwest Regional Office, 400 Waterfront Drive, Pittsburgh, PA 15222.

Trollinger Consulting Group, uniformed pension administrators, notified the Township, that the established procedure of pension cost of living adjustments are based on the percentage change in the applicable Consumer Price Index from October 2008 to October 2009. All the changes in the relevant indexes are negative. The Social Security Administration will not be granting COLAS for the same reason. As a result monthly benefit amounts will remain the same as 2009.

Range Resources has notified the Township of their intent to submit a water management plan to DEP for the withdrawal of water for gas exploration. Two of the proposed water withdrawal points are interconnections with PA American Water. The water withdrawal locations were mapped.

Ditched a small area on Paxton Road near the first house on the left.

Paved-Potholes all around the Township. Installing gravel in the alleys in Allison and Moninger area.

Storm Drains – Repaired a storm drain at the corner of Barnickel and Arthur Road. Working on a storm drain on Wylie Avenue.

Trees – Due to heavy winds last week the crew was out twice last week cleaning up trees on Ryburn Road, Washington Avenue, Arthur Road and Paxton Farm Road.

Street Signs – Repairing Street signs in the township Thorne Street, Small Street, Short and Pike Street.

There is a water problem on Reed Avenue we are looking for a solution.

Mr. Metzler reported that he had talked to Mr. Trapuzzano, Thorne Street – There is no berm on Thorn Street and the road is eroding. Mr. Metzler asked if this could be placed on the schedule for road repairs. The alley has been raised over the years due to construction on the lots behind Mr. Trapuzzano's residence causing water runoff into his lot. He asked if there could be a solution to improve the storm drain installed in the area.
