Mrs. Yeager was concern of the activity on the property across the street (owned by the township). Mrs. Yeager was informed that property is being cleared for a range for the Police Department to do their qualifying. The property is also to be as a future park. There are no immediate plans for development.

# **STAFF REPORTS:**

### Township Manager – Samuel R. Stockton

Executed and sent Indiana Avenue Storm Water Project Change Order to Widmer Engineering for handling.

Drafted and sent Pennsylvania Trolley Museum LSA letter of support.

Called Mark Cain of Pa American Water concerning a leak on Forest Avenue. He is aware of it but is too busy to address it at this time.

Drafted and sent notice to Chartiers-Houston School District that the Board waived permit and inspection fees required and performed by the Township. Any fees incurred by the Township would be forwarded to them for payment.

Edited and sent the legal ad to the *Observer Reporter* for 2010 proposed Sewer Rehabilitation Project.

The Director of Public Works and I met with two Range Resources representatives concerning the condition of the McConnell's Mills and I submitted a report concerning the meeting to the Board of Supervisors.

Sent back-up generator kW to the Township Engineer as requested.

Completed and sent the 2011 Employee Medical and Vision Census to Simpson and McCready.

Completed and returned the 2010 Road Improvement Project Agreements to the Township Engineer.

Sent a copy of the Solicitor's opinion to the Board of Supervisors on the 2010 Township Paving Project bidding and award process to PA DOT Municipal Services.

Drafted and placed a legal ad to sell two Township vehicles.

Contacted PNC Bank to begin the financing process for the front-end loader. Sent financial information requested.

The State is auditing the Uniformed and Non-Uniformed Pensions for 2007-2008-2009.

According to PA DOT Race Track Road in the area of the RR Crossing will be closed from October 9th-11<sup>th</sup> to repair the crossing.

Sent Chartiers Township's invoices from 2006 to date for the Route 18 Sewer Project in the amount of \$175,587.83 to the Army Corps of Engineers and requested \$130,940.87 in reimbursement.

Contacted the Chairman of Canton Township Board of Supervisors and requested copies of their invoices for the last six years so I can send them to the Army Corps of Engineers for reimbursement.

Took the Caterpillar front-end loader off the insurance and put the new JCB frontend loader on the insurance.

### **Correspondence of Note:**

PA DOT sent notice of our estimated 2011 Liquid Fuels Allocation of \$203,489.70. 2010 allocation was \$203,623.94. Difference of \$134.24.

The Redevelopment Authority of Washington County notified the Township it is eligible to receive a 2011 CDBG Fund allotment of \$95,300.00.

Received a thank you letter from the U.S. Census Bureau for partnering with them on the 2010 Census.

### Pubic Works Director – Edward Jeffries

Trucks – 1995 International bed has been completed and we will deliver the truck to K&P in the morning to install the bed. All other equipment has been repaired and working fine. The new front-end loader has arrived and has been put to work. The old Explorer for Harold will need a front axle seal, an oil pan, 4 shocks, a link pin, and upper and lower ball joints all this with labor will be around \$1,000.00 or more.

Paved-Potholes – Patched potholes through out the township. The soft spots on Jaspen Way we were waiting for the PA1 to clear. We will be clear to start the job on Wednesday weather permitting.

Storm Drains – We have repaired a storm drain at 5 Barnickel Street. We will be repairing a storm drain on Allison Hollow Road, as the weather will permit.

Guide rails - None

Parks – Arnold Park has been winterized and is locked for the winter. The basketball hoops at Allison Park have been installed.

### Planning/Zoning Officer – Harold Ivery Jr.

Mr. Ivery presented the Rea Jones Subdivision Plan #3. The Engineer is to submit an AUTOCAD. Utilities are noted on the plan, but not drawn on the plan. This is a nonbuildable lot. The Subdivision was not approved. This is to be followed up with the Engineer to determine the value of requiring an AUTOCAD drawing.

### Solicitor – James Liekar

The ordinance for the Codification of Township Ordinances has been advertised for the next meeting.

Additional changes in the Oil and Gas Ordinance were sent to Mr. Stockton. The Board is to review it and any changes Mr. Liekar asked they be given to the Township Manager.

Keystone Tax Service was awarded the County Earned Income Tax Collection beginning in 2012. The Local Service Tax is an option if you want them to collect it. They are hoping to make all the ordinances the same to deal with the nonresident tax.

Received a call from a resident concern surveyors on his property. When he inquired as to why they were on his property, they said they were doing something for Range Resources. They couldn't tell them what was going on. Based on the discussion I had with the resident, I passed the information on to Jim to add language to our draft ordinance requiring prior notification by gas/oil companies before any development activity could begin.
