One property owner has two laterals coming out of the basement of their home and due to gravity flow it is recommended that a sump pump be installed at the cost of \$5,895.00.

Motion carried

A motion was made by Mr. Kiehl and seconded by Mr. Marcischak to adopt Ordinance #336 prohibiting parking on the north side of West Pike Street from Ryan Lane to Country Club Road. Motion carried. (It is noted the Board received letters from the Meadow Lands United Methodist Church expressing their concern of the loss of parking in that area and Mr. Michael Crabtree, also expressing a concern of the impact of availability parking for his tenants at 585 and 591 Pike Street).

A motion was made by Mr. Kiehl and seconded by Mr. Marcischak to adopt Ordinance #335 to amend the Zoning Ordinance Chapter 122 Burning, Outdoor, with the modification that in case of an emergency or imminent emergency the Burn Ban declared by the Chairman until the next regular or special scheduled meeting after the declaration, unless such action is ratified by the Board at a regular of special public meeting. Motion carried.

A motion was made by Mr. Kiehl and seconded by Mr. Marcischak to award the 2012 Sewer Rehabilitation Project Bid to Process Contracting Company Inc., PO Box 600, Irwin, PA 15642 for the total bid of \$120,830.00. Motion carried.

A motion was made by Mr. Kiehl and seconded by Mr. Marcischak to award the 2012 Road Paving Project Bid to Donegal Construction Corporation, 1235Marguerite Lake Road, Greensburg, PA 15601 for the total bid of \$117,288.50. Motion carried.
