APPLICANT'S TESTIMONY:

<u>Attorney Gary Sweat</u> representing Mr. Quarture presented extensive background information and accompanying detailed property views, deeds and current usages in Exhibits A-G.

<u>Keith Straight, PE with T3 Global Strategies</u> presented visual mapping as he detailed the property boundaries, aerial overview and topography synopsis.

Anthony Quarture of 275 Johnson Road, Canonsburg (Property Owner/Applicant) provided details of his preparation, usage plans, access revisions and enhancements and beneficial growth opportunities based on the Township's Comprehensive Plan.

BOARD COMMENTS / QUESTIONS:

Supervisor Marcischak commended Mr. Quarture on his diligence and preparation in working with the adjacent property owners and communicating his intended usages for the property if it is zoned Industrial.

Courtney Looman of 34 Putorti Lane expressed her opposition to the rezoning change.

Roll Call Vote: Mr. Marcischak yes; Mr. Spin yes; Mr. Friend yes. The motion carried 3-0.
