## **Burning Permit Guidelines and Conditions**

**Burning Permits are subject to the following regulations (Please initial each statement):**

1. No hazardous materials may be burned; such fires shall be supervised; at the end of the workday, sunset at the latest, all fires must be extinguished and not permitted to smolder overnight.

2. No burning will be permitted on Sundays or holidays.

3. No burning shall be permitted before 9:00AM prevailing time.

4. Applications made for a permit under Chapter 122 (Outdoor Burning) must be made at least three (3) working days prior to date requested.

5. Any permit issued pursuant to Chapter 122 (Outdoor Burning) shall be for a specific period of time and specific location as requested on the application.

6. Any application submitted pursuant to Chapter 122 (Outdoor Burning) shall be on a form provided by the Township (as provided on the attached application).

7. No application shall be considered until the completed application is submitted to the Zoning Officer and the application fee is paid.

8. This permit does not supersede any state or federal permit requirements, and any person burning in Chartiers Township must use due diligence to determine the necessity of any state and/or federal permits and acquire the same.
