1. A motion was made by Mr. Metzler and seconded by Mr. Marcischak to approve the Arden Mills Lot 405 Simple Subdivision as recommended by the Community Development Coordinator and Township Engineer and conditional upon satisfaction of the outstanding items in the Township Engineer's letter dated December 9, 2015. All Supervisors voted yes. The motion was carried.

Mr. Kiehl:

Mr. Kiehl recognized Richard W. Metzler- Vice-Chairman. Mr. Metzler was appointed to the Board April 9, 2009. He served as Chairman from 2012-2013. - 3. A motion was made by Mr. Metzler and seconded by Mr. Marcischak to approve contractor payment request No. 9 (Final) from Mele Mechanical for the Chartiers Township Community Center in the amount of \$9,151.89 as recommended by the project architect in the application and certificate for payment dated December 15, 2015. All Supervisors voted yes. The motion was carried.
- 4. A motion was made by Mr. Metzler and seconded by Mr. Marcischak to award the bid for the 2015 winter material bid for up to 600 tons of Type III A Anti-Skid to Thomas and Son Trucking of Bulger, PA for the bid amount of \$18.89 per ton as recommended by the Township Manager and Director of Public Works and in accordance with the public bid opening of December 11, 2015. All Supervisors voted yes. The motion was carried.

NEW BUSINESS:

1. A motion was made by Mr. Metzler and seconded by Mr. Marcischak to approve the contract by and between Chartiers Township and the Chatiers Township Police Officers as recommended by the Township Manager. All Supervisors voted yes. The motion was carried.

- 2. A motion was made by Mr. Metzler and seconded by Mr. Marcischak to approve a settlement agreement and general release with Curtis Main as recommended by the Township Manager and Solicitor. All Supervisors voted yes. The motion was carried.
- 3. A motion was made by Mr. Metzler and seconded by Mr. Marcischak to authorize payment of invoices. (General Fund: Ck. #30681-30697: \$120,819; Act 13 Impact Fee Fund: Ck. #1089: \$237.50; Revenue Gaming Fund: Ck. #1043: \$49,279.00; Midland Sewer Fund: Ck. #1054: \$950.00; Sewer Fund: Ck. #2913-2914: \$1,677.87; Local Services Taxes: Ck. #1091-#1093: \$1,374.19: Capital Reserve Fund: Ck. #1078-1081: \$30,848.85; Grand Total All Funds: \$205,187.12).
