## Sign Application Guidelines

### **Application Information:**

- An application will be accepted and considered administratively complete if the following materials are submitted:
  - Signed application
  - Non-refundable application fee (if multiple signs are requested, a fee is required for each proposed sign)
    - 0 to 25 square feet: \$25.00
    - 26 to 99 square feet: \$50.00
    - 100+ square feet: \$100.00
    - Billboards: \$400.00
  - Survey of the subject property noting the location of all building footprints, paved areas, property lines, setbacks, and the proposed signs
  - Renderings of the proposed signs
- An approved sign permit does not take the place of the necessary building and electrical permits. Applicants and their contractors should seek approvals from the building and electrical inspectors as required.
