Zoning Hearing Board Guidelines

Application Information:

- Applications are due at least thirty (30) calendar days prior to a hearing (thirty (30) days prior to the third Monday of the month)
- An application will be accepted and considered administratively complete if the following materials are submitted:
 - Signed and notarized application
 - Non-refundable application fee: \$300.00
 - Applicant is responsible for additional fees if necessary
 - Ten (10) copies of the following
 - Project narrative (additional information about the request)
 - Survey of the property in question (including all relevant hearing details: setback lines, proposed building footprint, property lines, etc.) – if necessary
 - Renderings of the proposed improvements – if necessary
 - Any other relevant application materials

Hearing Information:

- Prior to the hearing, Chartiers Township will:
 - Post the subject property (at least seven (7) days prior to the hearing)
 - Mail notices to all adjoining property owners and those within 300 feet of the subject property (not more than thirty (30) days prior, nor seven (7) days before the hearing)
 - Advertise the hearing in a newspaper of general circulation in the Township (once each week for two (2) successive weeks (not more than thirty (30) days prior, nor seven (7) days before the hearing)
- Zoning Hearing Board hearings are held the third Monday of the month at 7:00PM in the Chartiers Township Municipal Building, 2 Buccaneer Drive, Houston PA 15342
- The Applicant(s) or their designated representative(s) must attend the hearing
- The Zoning Hearing Board, by law, reserves the right to make a final decision within forty five (45) days of the hearing
- The findings of fact, conclusions of law, and decision will be sent by certified mail after the hearing
