THE ZONING HEARING BOARD RESERVES THE RIGHT, BY LAW, TO MAKE A FINAL DECISION WITHIN 45 DAYS OF THE HEARING. APPLICANT MUST BE PRESENT OR REPRESENTED AT HEARING. APPLICANT SUBJECT TO ADDITIONAL FEES, WHEN NECESSARY.
